PRACTICAL LEGAL DESCRIPTION

Located in the Village of Stockbridge, Ingham County, Michigan.

Point of Beginning at the SW corner of the ROW at the intersection of W Elizabeth Street and N Wood Street;

North along the west ROW line of Wood Street to the NE corner of parcel 33-42-16-27-231-016;

Northwest along the south ROW line of Main Street to the NE corner of parcel 33-42-16-27-203-002;

South to the SE corner of parcel 33-42-16-27-203-002;

Northwest to an interior corner, then south to the SE corner, then northwest to the SW corner of parcel 33-42-16-27-203-001;

North to the SE corner of parcel 33-42-16-27-202-002;

Northwest to the SW corner, then north to the NW corner of parcel 33-42-16-27-202-001;

Southeast along the north ROW line of Main Street to the SW corner of parcel 33-42-16-27-201-006;

North to an interior corner, then west to the SW corner, then north to the NW corner, then east to the NE corner of parcel 33-42-16-22-400-015;

South to the SE corner of parcel 33-42-16-27-201-005;

Southeast along the north ROW of Main Street to the SW corner of parcel 33-42-16-27-226-015;

North to the NW corner of parcel 33-42-16-27-226-015;

East to the SW corner, then north to the NW corner of parcel 33-42-16-22-400-008;

East to the centerline of N Clinton Street;

North along the centerline of N Clinton Street to the NW corner, then east along the Village boundary to the NE corner of parcel 33-42-16-23-351-001;

South to the SE corner of parcel 33-42-16-23-351-007 at the centerline of the Lowe Lake Drain;

Southwest along the centerline of the Lowe Lake Drain to the South corner of parcel 33-42-16-23-351-006;

West to the SW corner of parcel 33-42-16-23-351-005;

South along the centerline of N Clinton Street to the north ROW line of E Morton Street;

East to the NE corner of the ROW at the intersection of E Morton Street and N Center Street;



South along the east ROW line of N Center Street to the SE corner of the ROW at the intersection of N Center Street and Willow Street;

West along the south ROW line of Willow Street to the NE corner of parcel 33-42-16-26-105-001;

South along the irregular eastern lot lines of parcel 33-42-16-26-105-001, parcel 33-42-16-26-105-002, and parcel 33-42-16-26-105-004 to the SE corner of parcel 33-42-16-26-105-004;

East along the north ROW line of E Herbert Street to the NE corner of the ROW at the intersection of E Herbert Street and N Center Street;

South along the east ROW line of N Center Street to the NE corner of the ROW at the intersection of S Center Street and E Vernal Avenue:

West along the north ROW line of E Vernal Avenue to the SW corner of parcel 33-42-16-26-151-009;

North to the NW corner of parcel 33-42-16-26-151-007;

West to the SW corner of parcel 33-42-16-26-151-002;

South along the east ROW line of S Clinton Street to the irregularly shaped Lakelands State Park Trail ROW;

Northeasterly along the irregular property line of the Lakelands State Park Trail ROW to the SW corner of parcel 33-42-16-26-164-001:

South to an internal corner, then east to the NE corner of parcel 33-42-16-26-326-001;

South to the SE corner of parcel 33-42-16-26-326-001;

West to the SW corner of parcel 33-42-16-27-476-010;

North along the Village boundary to the NW corner of parcel 33-42-16-27-476-002;

Northeast to the N corner of parcel 33-42-16-27-476-002:

East to the west ROW line of S Clinton Street;

North along the west ROW line of S Clinton Street to the SE corner of parcel 33-42-16-27-284-003;

West to the SW corner, then north to the NW corner of parcel 33-42-16-27-284-003;

West along the south ROW line of W Elizabeth Street to the SW corner of the ROW at the intersection of W Elizabeth Street and N Wood Street, the Point of Beginning.
