SDA Chairperson Ludtke discussed the \$350,000 loan funding. Discussion of the downtown street lighting, sidewalks etc. with Sam Lovell and Brian Doud. Blue prints on display at the Village office.

Motion by Chamberlain, support by Myer, to amend the SDA budget to show \$15,200.00 from Recreation to Acquisition Committee, allowing to pay off land contracts. Carried.

Variance denied. (2/3 vote required.)

Motion by Lehman, support by Dyer, to amend the SDA Ordinance #1100, adopted on May 6, 1985, Subsection (c) of Section 5, to rewright the 5th. sentence to read as follows: The Board shall adopt rules consistent with Act No. 267 of the Public Acts of 1976 governing the procedure and the hold of regular meetings which whall be held no earlier than 7:00 P.M., Tuesday through Thursday, subject to the approval of the Council. SECTION 1.	Subsection	(C)	of	Section	5	of	Ordinance	No.	1100

enacted May 6, 1986, is amended to read as follows:
