# VILLAGE OF STOCKBRIDGE ORDINANCE NO. TO AMEND THE STOCKBRIDGE VILLAGE CODE

An Ordinance to amend Sections 2-121 of Chapter 2, Article IV, Division 2 of The Stockbridge Village Code, being Ordinance No. \_\_\_\_ of the Village of Stockbridge.

WHEREAS, Section 4(8) of Act 197 permits a municipality that has a population of less than 5,000 to, by ordinance, establish its planning commission as the DDA Board; and

WHEREAS, the Village Council desires to establish the Village's Planning Commission as the DDA Board.

NOW, THEREFORE, the Village of Stockbridge ordains:

Section 2-121 of the Stockbridge Village Code is hereby amended to read as follows:

Sec. 2-121. Generally.

The authority shall be under the supervision and control of the Board of Directors consisting of the members duly serving as the Village of Stockbridge Planning Commission, as permitted by Section 4(8) of Act 197. The chairperson of the Board shall be elected by the members of the Board.

#### EFFECTIVE DATE.

This Ordinance was approved and adopted by the Village of Stockbridge, Ingham County. Michigan on September 7, 200, 2010, and is ordered to take immediate effect. The Clerk shall cause publication of this ordinance or a synopsis of this ordinance in a newspaper having general circulation in the Village of Stockbridge within fifteen days of the date of its adoption pursuant to the provisions of Public Act No. 3 of 1895 as amended.
