REPORT OF VILLAGE COUNCIL MEETING – Russ Mackinder gave; Stockbridge Manufacturing received tax abatement from the Village, Zoning changes on parking lots were tabled.

REPORT OF SDDA EXECUTIVE DIRECTOR – Marcus McKissic presented and talked about the SDDA workshop and its success, the Minix Lot has been graveled, discussed Ransom/Consumers easement.

OLD BUSINESS

• **Wood Street Lot-** Mid Michigan Rubbish is handling the dumpsters located in the Wood Street Lot. Recap of the deed: a vote to deed the Wood Street lot to the Village Council, failed in March because of a 4-4 tie vote. Doug Mills mentioned putting protective posts to protect the electrical panels in the Wood Street Lot. Talked about plowing the Wood Street, Minix, Center Street, and Veterans Memorial lots. **Motion** Doug Mills **second** Scott Spadafore to seek bids to plow the 4 SDDA parking lots, with the executive committee approving the format of the bid before it is published. **No discussion- verbal motion carries 6-0**.

- Sidewalk Maintenance Agreement- Motion Scott Spadafore second Annabell Howard to seek 2 bids for snow removal 1.) SDDA perpetual sidewalk areas and 2.) TIF Downtown Sidewalks with the executive committee approving the format before it is published. No discussion- verbal motion carries 6-0.
- **Minix/ Blossom-** Minix has been graveled. Meeting with Blossom at 10am on Thursday, November 19,2009
- **Birchmeier Update-** An Ad Hoc committee with Russ Mackinder, Sherrill Rodriguez, Anne Moceri was formed to investigate and see if the property is still available.
- **Signage** Signage is being considered for the trail head, potential designs are to be brought before the board. Also talked about revamping Village signs.
